I. Acknowledgement

III. Under Section 314 (a)(I) of the CRRSAA Act (HEERF II) and under the American Rescue Plan of 2021, [ARP(a)(1) and (a)(4)] (HEERF III), our institution has established the following guidelines to determine eligibility of its students.

It is established as one of its purposes to provide a subsidy to students who are eligible for expenses related to their education, due to COVID-19, including materials and technology for teaching, as well such as food, housing, health, and childcare.

a. Method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive.

1. These emergency aid will be awarded in two parts for each student. In addition to the eligibility requirements, the financial need established in the Application for Financial Aid (FAFSA) will be considered, using the Expected Family Contribution (EFC) therein. The remainder was distributed equally among eligible students.

a. First distribution:

1. Students with an EFC 0., on their Financial Aid Application (FAFSA) will be awarded a grant of \$ 1,500.00.
2. Students who do not have an EFC 0 will be awarded a grant of \$ 1,200.00.

b. Second distribution:

1. Students with an EFC 0., on their Financial Aid Application (FAFSA) will be awarded a grant of \$ 1,200.00.
2. Students who do not have an EFC 0 will be awarded a grant of \$900.00.

c. Third distribution:

1. All active qualifying students were awarded \$700.00.
2. Students received an email notifying the eligibility requirements and if they were eligible, the amount awarded and the distribution date (Refer to Part IV).

b. Eligibility Requirements

All students to receive the granting of these emergency aid must meet the following eligibility requirements:

1. Be a US citizen or permanent resident of the United States or eligible alien.
2. Have a valid social security number.
3. Be enrolled in a Title IV eligible program.
4. Have a high school diploma or its equivalent (GED).
5. Not be in default on a Title IV loan.
6. Have satisfactory academic progress, according to the Institution's Academic Progress Policy.
7. Be registered with the Selective Service (male ages 18 to 25).
8. Not have been convicted of possession or sale of drugs in federal or state jurisdiction.
9. Have completed your financial aid application (FAFSA).
10. Have completed the Financial Aid Verification process, if selected for verification.

c. Procedure for Granting and Distribution of Emergency Funds

1. The Office of Financial Aid and Registrar will evaluate and certify students who meet the eligibility requirements.
2. The Pell Grant Table will be used for the granting of funds, considering the EFC of each eligible student.
3. Each eligible student will be notified in writing of their eligibility via email.
4. Aid will be delivered through an official check from the Institution that will be delivered personally or, if it cannot be delivered personally, it will be sent to the student by certified mail.

This Eligibility Policy, Procedure and Distribution of HEERF II and III funds may be amended, if necessary, in compliance with the provisions of the Law.
